What is identity theft?

According to the Department of Justice Identity Theft includes all types of crime in which someone wrongfully obtains and uses another person's personal data in some way that involves fraud or deception, typically for economic gain.

Identity thieves steal your most personal information such as your social security number, your financial and bank account information, your email, physical address and even your social media profiles. It can be emotionally and financially devastating.

What is the Free Dark Web Email Scan?

Scans your email address only to detect if it appears on the dark web. If detected, member will be provided with protection tips and next step instructions.

What is the Dark Web?

The Dark Web is a place on the internet where cyber thieves hang out and buy and sell information.

There are signs that can help you determine if you've become a victim of identity theft, for instance:

- Unexplained activity on your accounts.
- Receiving calls or letters from debt collectors or business about services you did not buy.
- Receiving bills or other mail late, or not at all.
- Receiving credit cards you did not apply for or being denied credit for no apparent reason.
